Subject: Application of Electronic Cargo Tracking System (ECTS) for sealing and monitoring of goods to be deposited in Customs Bonded Warehouse under Chapter IX of the Customs Act, 1962- reg.

Attention of Importers, Customs Brokers, Warehouse licensees, members of trade and all other stakeholders is invited to the Public Notice No. 24/2021 dated 09.11.2021 and corrigendum dated 12.11.2021 issued by this office on the above mentioned subject.

2. With effect from 10.11.2021, a pilot project regarding ECTS was rolled out for movement of specified goods mentioned in the said Public Notice, from one Custom bonded warehouse to another Custom bonded warehouse both situated in Delhi, where the bill of entry for warehousing had been filed at ICD TKD under section 59 of Customs Act 1962.
3. Further, in order to extend the scope of this facility, the ECTS seal shall be mandatory for movement of all goods being transferred under bond to bond, from one Custom bonded warehouse to another Custom bonded warehouse both situated in Delhi w.e.f. 15.11.2021, and where the bill of entry for warehousing has been filed at ICD TKD, under section 59 of Customs Act 1962. However, in cases of extraordinary circumstances, the warehouse/buyer/importer may request in writing for the existing one-time seal for the concerned consignment and the same would be permitted with the approval of the Additional/Joint Commissioner in-charge of Bond section of Air Cargo Complex, Export.
4. All trade associations/members of Customs Brokers Association are requested to take note and publicize the contents of this Public Notice among their members/constituents.
5. For departmental officers, this may be treated as Standing Order.
