Trade Facility Circular No. 02/2016

Subject:- Clearance of Hand Carry Consignments of Precious Cargo at Terminal-3, IGI Airport, New Delhi reg.

Attention of all Exporters, Customs Brokers and Public is invited to the trade facility circular No. 01/2016 dated 11.02.2016 regarding implementation of EDI module for assessment of export consignments of precious cargo (Gems & Jewellery) at Air Cargo Complex, IGI Airport, New Delhi.

Subsequent to the issuance of above mentioned trade facility circular, the work of appraisalment and clearance of precious cargo (Gems & Jewellery) by Customs has been shifted from Jhandewalan Jewellery Complex, New Delhi to Air Cargo Terminal, IGI Airport, New Delhi and Office of the Jewellery Appraiser (Customs), Jhandewalan Jewellery Complex, New Delhi became non functional.

Representation have been received from the trade requesting that the appraisalment and clearance of the hand carried consignments of precious cargo export shipments for exhibitions, trade promotion tours etc. may be done at the International Airport itself.

The request has been examined and it has been decided that the appraisalment and sealing of the hand carried export consignments of precious cargo (Gems & Jewellery) meant for exhibitions, trade promotion tours etc. will henceforth be done at Indira Gandhi International Airport Itself.
