## PUBLIC NOTICE NO. 2017

Subject: Special measures for liquidation of pending Drawback claims

Attention of all exporters, CHAs, Shipping lines and members of the trade is drawn to the fact that a large number of Drawback claims are pending in various queues in EDI system in this Commissionerate. It is needless to say that the Department aims at disbursing duty Drawback claims of the exporters as soon as the EGM is filed in respect of the goods exported. However, in some categories of cases, the release of Drawback gets held up for a long time for want of appropriate action on the part of the exporter/CHA/shipping line/custodians. Therefore, it is in the interest of the exporters to check and obtain the current status of their Drawback claim immediately after Let Export Order (LEO) and after filing of EGM. The status of Drawback claim against any shipping bill can be seen at the website www.delhicustoms.gov.in along with reason of pendency.

2. It has been found that a large number of Drawback claims have been pending in "Query Raised" queue for very long time (Let export Order prior to 01.07.2017) on account of non-submission of proper reply by the exporters. All such exporters are, therefore, required to reply to the query on EDI system to the Assistant Commissioner (Drawback), Air Customs Export within 10 days from the date of issuance of this Public Notices. The exporters or their representatives can also personally explain to the Assistant Commissioner (Drawback) the response to queries during office hours on any of the following days:

- (i) 01.01.2018 to 05.01.2018
- (ii) 09.01.2018 to 16.01.2018
- (iii) 22.01.2018 to 29.01.2018
- 3. If the query is not replied satisfactorily before, 31.01.2018, the drawback claim shall be rejected and processed as "ZERO" Drawback for want of proper reply to the queries raised. For ready reference of all concerned, list of all pending Drawback claims in "Query Raised" queue obtained from the EDI system is attached with this Public Notice (Annexure-1).
