**Subject: Pilot implementation of paperless processing under SWIFT - Uploading of supporting documents regarding.**

Kind attention of all the Importers/Exporters, Custom House Brokers, Airlines, Trade, Customs Staff and Stakeholders is invited to the CBEC Circular No. 40/2017- Customs dated 13<sup>th</sup> October, 2017, and the Public Notice No. 08/2017 dated 20<sup>th</sup> October, 2017 issued by the office of the Chief Commissioner, Customs (DZ) on the subject above. The said Public Notice outlines procedure for pilot implementation of paperless processing under Single Window Interface for Facilitation of Trade (SWIFT).
