PUBLIC NOTICE NO. 2/2018

**Sub: -Implementation of E – waste (Management) Rules, 2016 & others - Regarding.**

Kind attention of all Importers, Custom Brokers, Members of Trade & Industry Association and others stakeholders is invited to the requirement of compliance to allied Acts & Laws as stipulated under Section 11 of the Customs Act, 1962.

2. Therefore, it is being reiterated that all formalities such as requirement of No Objection Certificate, registration or licenses (wherever applicable) be complied with, at the time of import.

3. Special attention is drawn to the following Acts, keeping in view that these commodities are frequently imported at this port:-

(a) E-Waste (Management) Rules, 2016; (excerpts)

(i) The import of electrical and electronic equipment shall be allowed only to producers having Extended Producer Responsibility authorisation at this port.

(ii) Imports or placement in the market for new electrical and electronic equipment shall be permitted only for those who are compliant to provisions of sub-rule (1) and sub rule (4) of rule 16 of the E-Waste (Management) Rules, 2016.

(iii) Other relevant provisions.


(b) Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016;

(c) Legal Metrology (Packaged Commodities) Rules, 2011.

(d) Indian Telegraph Act 1885 & Indian Telegraph Rules.

(e) India Wireless Act, 1933

4. Difficulties faced, if any, may be brought to the notice of the Joint Commissioner, ACC Import, NCH, New Delhi.


