PUBLIC NOTICE No. 07/2017

Subject :- Form Courier Bill of Entry-V (CBE-V) – Courier Bill Of Entry for dutiable goods

Kind attention of Exporters, Authorized Couriers, Express Industry Council of India, Members of trade and all concerned is invited to CBEC Notification No. 66 /2017-Customs (N.T.), Dated 30th June, 2017 wherein new format for Form Courier Bill of Entry-V (CBE-V), is prescribed.

2. In the above said new formats, it is seen that there is no specific Column for making entry of "Education/Secondary & Higher Education Cess/ADD/Safeguard Duty" which is required to be calculated on Basic Customs Duty. In the absence of any such Column, different Authorized Couriers are adopting different formats for including the Education/S&H Education Cess/ADD/Safeguard Duty, in the prescribed formats for assessment purpose.

3. In view of absence of any Column for Cess/ADD/Safe-guard Duty in the prescribed formats and to bring uniformity in the formats to be filed by the Authorized couriers, it has been decided that the Rate of Cess/ADD/Safe-guard Duty and Amount of Cess/ADD/Safe-guard Duty, should be included horizontally below the Basic Custom Duty (BCD) Column (No. 21) of the prescribed format of Form Courier Bill of Entry-V (CBE-V) issued by CBEC. The Column 21 will now mention "Duty Rate, Duty Amount, Cess/ADD/Safe-guard Duty Rate, Cess/ADD/Safe-guard Duty Amount".

4. Any difficulty in implementation of this Public Notice shall be reported to Additional Commissioner/Joint Commissioner, New Courier Terminal, Near I.G.I. Airport, New Delhi.
