**PUBLIC NOTICE No. 09/2017**

Attention of the Trade and Authorized Courier is invited to the provisions of the Customs Act, 1962 (hereinafter referred to as "the Act"), the Courier Imports and Exports (Electronic Declaration and Processing) Regulations, 2010 (hereinafter referred to as "the Regulations") issued in exercise of the powers conferred by Section 157 of the Act by the Central Board of Excise and Customs (CBEC) vide Notification No. 36/2010-Customs (NT) dated 05.05.2010, CBEC Circular No. 58/2016-Customs-IV dated 02.12.2016 and the procedures stipulated in the earlier Notifications, Public Notices, Circular, etc.

**2.0** In continuation of Public Notice No. 57/2017 Dated 19.07.2017 issued by this office vide C. No. VIII/Cus-Gen/NCT/CBEC Partner/ 1478/2017 and Public Notice No. 08/2017 Dated 03.08.2017 issued vide file of even no., the facility of application software known as Express Cargo Clearance System (ECCS) for online clearance of Import Bill of Entries (which was put into operation for clearance of imports covered under Courier Bill of Entry XI in the FedEx Terminal from 24.07.2017 and extended to DHL Terminal from 04.08.2017) is now being extended to FedEx & DHL Terminals for imports covered under CBE -XII/XIII/XIV from 16.08.2017 onwards for selected flights viz. 9W259, 9W263, SQ402, 9W017 for DHL and EK514, 9W271, UL1195, SQ406, KB204, 9W017, SQ402 for FedEx. Subsequently the facility of ECCS will be extended to all flights of FedEx and DHL Terminal as well as other Authorized Couriers of EICI terminal for imports covered under CBE -XII/XIII/XIV before the end of 31.08.2017.
