Subject :- Request to waive late filing fee due to system down for Budget Update- Regarding.

Attention of all Importers/Exporters, Custom Brokers, Custodians, General Trade, Partner Government Agencies (PGAs), all other stakeholders and all the taxpayers is invited to Union Budget 2022-2023 to be presented on 01st Feb 2022. Filing of Bills of Entry would not be available in ICEGATE from 17.00 Hrs. of 01st Feb 2022 till completion of updation of all budgetary changes in the ICES and filing of advance Bill of Entry for the consignments arriving on or after 1st Feb 2022 may create difficulty due to changes in the duty structure, if any, and it would require to be re-called and re-assessment.

2. In view of the above, "late fees" imposable in terms of Bill of Entry (Forms) Amendment Regulations, 2017 vide Notification No. 27/2017-Customs (N.T) dated 31.03.2017 will be waived off in respect of Bills of Entry, filed belatedly, which pertains to IGMs filed from 17.00 Hrs. of 01st Feb 2022 till completion of updation of all budgetary changes in the ICES System.

3. This Public Notice should be considered as Standing Order for the purpose of Officers and Staff of the department.
