PUBLIC NOTICE NO. 11/2020

Sub: Extension of Public Notice relating to the Import/Export of goods under various Export Promotion Schemes from ICD, Palwal-reg.

Attention of all importers, exporters, Customs Brokers, Shipping Lines/Agents and members of Trade and Industries is invited to Public Notice no06/2019 dated05.03.2019 issued by the Pr. Commissioner of Customs, ICD PPG & other ICDs and the below mentioned Customs Notification relating to the Import/Export of goods under various Export Promotion Scheme:-

- I. Notification No. 16/2015- Customs dated 01.04.2015- related to Export Promotion Capital Goods (EPCG) Scheme.
- II. Notification No. 18/2015-Customs dated 01.04.2015- related to Advance Authorization Scheme.
- III. Notification No. 19/2015- Customs dated 01.04.2015- related to Duty Free Import Authorization Scheme.
- IV. Notification No. 24/2015- Customs dated 08.04.2015- related to Merchandise Exports from India Scheme.
- V. Notification No. 25/2015- Customs dated 08.04.2015- related to Service Exports from India Scheme.
- 2. Various Sea-Ports, Airports, Inland Container Depot (ICDs) and Land Customs Station (LCSs) have been notified for imports and exports under the aforesaid export promotion schemes, in the above referred notifications. Further, as per provisos in these Notifications, the Commissioner of Customs have been empowered to permit imports and exports through any other Sea-ports, Airports, Inland Container Depot (ICDs) and Land Customs Station(LCSs) by issuing a special order or a Public Notice. In this regard, subject to such conditions as may be specified.
- 3. The aforesaid notifications do not include Inland Container Depot (ICD), Palwal(INPWL6), Village Janoli-Bhagola falling within the jurisdiction of Customs Commissionerate, ICD Patparganj & other ICDs, Delhi-110096. Accordingly, in view of the requests received from the custodian and with a view

to provide trade facilitation measures, it has been decided to permit import/export of all permissible goods from ICD Palwal (INPWL6) under above referred notifications.

- 4. Imports and Exports under this Public Notice shall be allowed only after fulfilment of conditions specified in the notifications mentioned at Para 1 above and any other conditions specified in the Handbook of Procedure/ Foreign Trade Policy 2015-2020 and various departmental instructions issued time-to-time.
- 5. All the trade Associations/Chamber of Commerce, Members of Regional Advisory Committee and Customs Brokers are requested to publicize the contents of this Public Notice among their members/Constituents for their information and necessary action.

6. This Public Notice is valid till 31.03.2021.
