Subject: Appointment of Custodian of Import & Export goods at ICD Garhi Harsaru - regarding

In modification of Notification No. 01/2015 dt. 28.05.2015 and Public Notice No. 23/2020 dt. 30.03.2020 and further in exercise of powers conferred upon the Commissioner under Section 45 of the Customs Act, 1962, I, Manish Saxena, Commissioner of Customs, ICD Patparganj & other ICDs, Near Gazipur village, New Delhi-110 096 hereby renew the appointment of M/s Gateway Rail Freight Limited, SF-7, D-2, Southern Park, Saket District Centre, Saket, New Delhi- 110 017 as the Custodian of imported goods received at the above mentioned Inland Container Depot at Garhi Harsaru, Gurgaon until these goods are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Act, ibid for a period of 10 years w.e.f. 01.07.2020. Similarly, they will also be the Custodian of export cargo brought into the above mentioned ICD Garhi Harsaru for stuffing, accountal, Customs examination and onward transshipment to the Gateway ports under Section 50 and 51 of the Customs Act, 1962. The Custodianship of M/s Gateway Rail Freight Limited is extended for a period of 10 years in terms of Board Circular No. 33/2016-Customs dated 22.07.2016 being AEO-LO client.

M/s Gateway Rail Freight Limited shall be required to comply with the provisions of Section 45(2) of the Act, ibid, as well as rules, regulations and instructions issued in this regard from time to time.
