

In the light of lock down due to outbreak of COVID19, there are several challenges being faced by trade viz: in clearance of cargo, transportation of cargo and in arranging the finance. To mitigate such challenges CONCOR, ICD/TKD is functioning 24\*7 as usual, even during this lockdown period with adequate measures in place to contain COVID19. Customs is also rendering it's services in usual course. To facilitate the trade further, CONCOR is pleased to inform all valuable customers that, following special concession in charges have been approved by competent authority to provide respite in these challenging times.

- 1) HNP charge, Ground rent on cargo (Warehouse Charges), and Auction Charges will not be applicable for the period from 22/03/2020 to 14/04/2020 (both days inclusive). This free time, as dies non will be over and above of the free time, which are being extended to customers for calculation of charges as per extant public tariff, if the container/cargo is cleared from ICD/TKD within one months of end of lockdown, i.e. 14/04/2020, as of now.
- 2) Terminal Service Charges on container and late payment surcharge will be waived off for the lockdown period, i.e. from 22/03/2020 to 14/04/2020 (both days inclusive).
