PUBLIC NOTICE No. /2020

Subject: Clearance of goods to SEZ- facilitation during lockdown period in view of outbreak of COVID-19 - reg.

Attention of the importers, Customs Brokers and all other stakeholders is invited to the above cited subject matter.

2. Presently, the imported goods, destined for importers located in Special Economic Zone (SEZs), are granted Out of Charge from ICD Tughlakabad, Delhi on the basis of hard copies of Duplicate and Quadruplicate copies of Bills of Entry, duly assessed by the proper officer of SEZ.

3. It has been brought to the notice of this office that due to lockdown imposed by the Government in view of outbreak of COVID-19, the Importers / Custom Brokers are unable to submit, duly assessed, duplicate and quadruplicate copies of Bills of Entry. Therefore, as a measure of trade facilitation, it has been decided that scanned copies of duplicate and quadruplicate copies of Bills of Entry may be sent to the port of import i.e. ICD Tughlakabad (Imports) to Deputy Commissioner of Customs (Import Shed - Admn.) at email ID sanjay.1210@gov.in, through the official e-mail ID of the concerned assessing officer of SEZ along with details of Customs Broker intending to clear the goods and contact number of Assessing officer at SEZ.

4. Such Bill of Entry would be accepted and OOC would be granted based on the documents so received and as per the prescribed procedure for clearance of goods from ICD Tughlakabad to SEZs, subject to an undertaking by the Importer / Customs Broker that he would submit hard copies of duplicate and quadruplicate copies of assessed Bills of Entry within a period of 15 days from the date the lock down is lifted.

5. The Deputy Commissioner of Customs (Import Shed - Admn.) of ICD Tughlakabad, would maintain a register for keeping record of OOC granted on the basis of such accepted scanned copies of Bills of Entry. He shall ensure that all


OOCs granted on the basis of scanned copies are matched with the hard copies so received within a period of 21 days from the date the lock down is lifted.

6. All trade associations/members of Customs Brokers Association are requested to take note and publicize the contents of this Public Notice among their members/constituents.

7. For the departmental officers, this may be treated as Standing Order.

8. Difficulties, if any, may be brought to the notice of Additional Commissioner of Customs (Technical), ICD, Import, TKD, New Delhi.


