**Subject: Implementation of the Phase Automation of issuance of Space Certificate, Annexure – C and Form Annexure-III (Form as provided in Regulation 3 of Warehoused Goods (Removal) Regulations, 2016), with respect to Electronic Cargo Tracking System (ECTS) for sealing and monitoring of goods to be deposited in Customs Bonded Warehouses under Chapter IX of the Customs Act, 1962-- reg.**

Attention is invited to Public Notice No. 36/2021 dated 07.12.2021 issued under F. No. VIII/ICD/TKD/IMP/PN & SO/11/2021 whereby it was envisaged that to extend the scope of the facility and moving towards automation leading to a paperless work environment, a date will be notified separately through Public Notice, for movement of all goods imported at ICD(Import), Tughlakabad, New Delhi from ICD, Tughlakabad to the designated Customs Bonded Warehouse situated within Delhi or for movement of all goods imported at ICD(Import), Tughlakabad, New Delhi from one Custom Bonded Warehouse (situated within Delhi) to another (situated within Delhi), as well as Bond to Bond sale where movements of goods are not involved, Annexure-C will be generated and will be issued through ECTS portal.


2. It is informed that the aforesaid automation of documents is scheduled from 1<sup>st</sup> Feb-2022. In case of extraordinary circumstances, the importer transferee Customs Broker may request in writing for manual processing of Annexure-C, for the concerned consignment and the same would be permitted with the approval of the Additional Joint Commissioner in-charge (Bond).

3. All trade associations/members of Customs Brokers Association are required to take note and publicize the contents of this Public Notice among their members constituents.

4. For departmental officers, this may be treated as Standing Order.
