Subject:- Request to waive late filing fee due to system down for Budget Update- reg.

Attention of all Importers/Exporters, Custom Brokers, Custodians, General Trade, Partner Government Agencies (PGAs), all other stakeholders and all the **taxpayers is invited to** Union Budget 2022-2023 which was presented on 01 Feb 2022. Filing of Bills of Entry was not available in ICEGATE from 17.00 Hrs. of 01st Feb 2022 till completion of updation of all budgetary changes in the ICES (23.59 hrs of 02nd February 2022) and filing of advance Bill of Entry for the consignments arriving on or after 1st Feb 2022 created difficulty due to changes in the duty structure, if any, and it might be required to be re-called and re-assessed.

2. In view of the above, "late fees" imposable in terms of Bill of Entry (Forms) Amendment Regulations, 2017 vide Notification No. 27/2017-Customs (N.T) dated 31.03.2017 will be waived off in respect of Bills of Entry, filed belatedly, which pertains to IGMs filed from 17.00 Hrs. of 01st Feb 2022 till completion of updation of all **budgetary changes in the ICES System** (23:59 hrs of 02nd February 2022).

3. This Public Notice should be considered as Standing Order for the purpose of Officers and Staff of the department.
