Subject: Levy of Late Fee charges @ Rs. 5000/- by EDI system due to system error- Reg

Attention of Importers/Exporters, Custom Brokers, Trade, Customs Staff and other stakeholders is invited to the Amendment in Section 46 of Customs Act, 1962 as per the Finance Act 2021 as detailed in Notification 35/2021 Customs[NT] dated 29.03.2021, and elaborated in Board's Circular No. 08/2021 dated 29.03.2021.

2. As per the said Notification, Bills of Entry have to be filed before the end of the day (including holidays) preceding the day on which the vehicle (which includes train) carrying the goods arrives at the inland container depot.
3. Due to system software error, in some cases where Bills of Entry were filed in time as per the amended provisions, charges @ Rs. 5000/- per day were found to be levied. On being noticed, immediate instructions were issued to all the group AC/DCs asking them to consider the waiver of the said amount which was erroneously levied, without forwarding the files for waiver to JC/ADC, so as to facilitate the trade. The system glitch has been resolved as of now. However, in case trade still has some unresolved issues in this matter, they may approach the Turant Seva Kendra at tskii.icdtkdimp@gov.in.
