Subject: Entry of proper bond details at the time of filing of Bills of Entry – reg.

It has been noticed that various requests for re-call of the bills of entry are being received by the appraising groups for deletion of bank guarantee amount. On analysis of the issue, it has emerged that the system picks the bank guarantee of 100% when the importer/customs broker fails to enter correct bond details at the time of filing the bill of entry.

- Such requests are causing inordinate delays in the processing of the bills of entry and the officers have to bear with the avoidable additional work load.
- In this regard, in all cases where submission of bond is mandatory, the importers/customs brokers are hereby advised to exercise due diligence while entering the bond details at the time of filing the bill of entry. Deviations, if any, will be viewed strictly, and such requests for deletion of bank guarantee will be considered only after levy of a penalty of Rs.1000/- under Section 117 of the Customs Act, 1962.
- The Customs Brokers Association is requested to take note and publicize the content of this public notice among their members.
- For the departmental officers, this may be treated as a Standing Order.
- Any difficulty in implementing this Public Notice may be brought to the notice of the Joint Commissioner of Customs.
- This issues with approval of the Commissioner of Customs (Import), ICD, TKD, New Delhi.
