
**Subject: Alignment of State Codes of ICES with GSTN-Implementation of Changes in ICES-regarding.**

Kind attention of the Importers Customs House Agents/Customs Brokers/ members of Trade is invited to implementation of Goods and Service Tax (GST) in India w.e.f. 01.07.2017. In this regard, certain changes are anticipated in Bills of Entry declaration in alignment with proposed GST implementation.

2. Currently in ICES, State Codes are maintained as per RBI List, and is being used for declaration in Bills of Entry and Shipping Bills for various purposes (State of Origin in Shipping Bill and State Code for VAT Registration). As an initial step towards GST implementation, State Code is given in 'Annexure-I'(copy enclosed). NIC RES package has already been modified to reflect this change. This change is proposed to be implemented from 28.06.2017. The trade is advised to make note of the changes and declare the new State code to avoid problems at ICEGATE End.

3. All the trade Association/ Chamber of Commerce/Members of Regional advisory Committees and Customs House Agents Association are requested to publicize the contents of this Trade Notice among their members/ constituents.
