**Sub: Customs clearances at ICD Tughlakabad (Import) on all 7 days of a week including public holidays- Reg.**

Attention of all Importers/Exporters, Customs Brokers, General Trade, Partner Government Agencies (PGAs), Custodians and all stakeholders is invited to various measures taken from time to time by ICD-Tughlakabad (Import) to facilitate Customs clearance.

2. In addition to existing Customs clearance facilities from Monday to Saturday, as a trade facilitation measure it has been decided to extend customs clearance facility for 7 days a week, including Sundays and public holidays, at ICD-Tughlakabad (Import) which is one of the largest land port of the Country. The facility at ICD Tughlakabad (Import) shall be available beginning from 14.11.2021 (Sunday) during normal office hours, between 9:30 am to 6:00 pm.


3. This extended facility will be available to RMS facilitated cargo of import and cargo under examination post assessment. To avail clearance of cargo, delivery order (DO) of shipping lines needs to be obtained till Friday, any Bond/Bank Guarantee be executed till Saturday and any NOC (No Objection Certificate) from Partner Government Agency (PGA) be obtained till Friday.

4. The Custodian shall ensure that gate passes are generated on all 7 days of a week to facilitate clearances. The Custodians shall make all necessary arrangements with regard to infrastructure, space, machinery and human resources for giving clearances.

5. All stakeholders like custodian, importer & exporter, Customs broker, should coordinate with shipping lines in this regard for seamless flow of DO (Delivery Order).

6. All trade associations/members of Customs Brokers Association etc are requested to take note and publicize the contents of this Public Notice among their members/constituents.

7. Difficulty, if any, may be brought to the notice of the Joint Commissioner of Customs (Import), ICD, TKD New Delhi at email id jc1.icdtkdimp@gov.in.
8. For departmental officers, this may be treated as Standing Order.
