PUBLIC NOTICE NO. 14/2022

Subject: Special drive to declog X-Bond Bills of Entries pending in EDI System for payment upto 31.07.2022 - reg.

Pursuant to a recent review of the warehoused goods attention of Importers, Customs Brokers, Warehouse licensees, members of trade and all other stakeholders is invited to Ex-Bond Bills of Entry filed but pending for long in EDI for the payment of duty.

2. It is observed that there are a numerous Ex-Bond Bills of Entry pending for payment of duty for more than one month, in few cases for years. It was also submitted by ISWAI – (International Spirits & Wines Association of India) that because of a bundling up Ex-Bond Bills of Entry pending for payment in the EDI System, the stocks of the importer get blocked until payment of duty. and they are unable to get Customs clearance of this stock if the duty on these Ex-Bond Bills of Entry is not paid.

3. It is evident from the EDI system that at present a huge quantity of stock is blocked on this account and the owners of the goods are not able to file Ex-Bond BE for the same.

4. Therefore, all concerned stakeholders are advised to make payment of such Ex-Bond Bills of Entry before 15.10.2022; failing which action for purging all the Ex-Bond Bills of Entry filed up to 31.07.2022 from the EDI system will be initiated.

5. All trade associations/members of Customs Broker Association are hereby requested to take note and publicize the contents of this Public Notice among their members/constituents.

6. Difficulty, if any, may be brought to the notice of the Joint Commissioner of Customs, Bond, ICD, TKD Import Commissionerate

7. This issues with the approval of the Commissioner of Customs, ICD, TKD Import Commissionerate.
