**Subject: ICES Application Migration to Solaris-regarding.**

This is for general information that ICES application is being migrated to a new platform. The migration of the application is planned from 2300 hrs on Saturday, 16th June 2018 to 1800 hrs on Sunday, 17th June 2018. During this period, the application would not be available to the trade users, participating government agencies and CBIC Officials. A ticker has also been placed on the application page informing about the planned downtime.

2. In view of the above, the following Advisory is being issued for the benefit of all concerned:

i) The filing of declarations (Bill of Entry, Shipping Bill, Import General Manifest and Export General Manifest) would be halted at **2000 hours on 16.06.2018 (Saturday)**.

ii) Section 48 approvals shall also be stopped at **2000 hours on 16.06.2018 (Saturday)**.

iii) Once migrated, another round of user testing shall be undertaken before the application is made available to all the users, **expectedly** from 1800 hours on 17.06.2018. In case of any extension in timelines beyond that specified above, for any unforeseen reasons whatsoever, suitable and necessary instructions/advisory would be communicated.
