Sub- Simplified Processing of AEO T-1 applications-reg.

Attention of all trade bodies, importers and exporters is drawn to Board's Circular No. 26/2018 – Customs, dated 10th August 2018 regarding simplification and rationalization of processing of AEO-T1 application.

2. In terms of the aforesaid Circular dated 10.08.2018, the process of AEO T-1 certification has been further simplified. The present Annexures for AEO T-1, viz., A, C, D, E.1, E.1, E.2, E.3 and E.4 have been **replaced** by Annexure 1 and 2 (copies enclosed). All the new applications will henceforth be filed by the eligible applicants in the new Annexures.

3. Further, the process of accreditation of AEO T1 has been decentralised at the Zonal Level. The application has to be filed in the Zonal AEO Cell for processing and its final acceptance or rejection will be decided by Zonal AEO Programme Manager.

4. In view of the above changes, the **Zonal AEO Cell** for Delhi Customs Zone and Delhi Customs Preventive Zone has been re-constituted as under:

1. Shri Sunil Kumar Sinha, Commissioner and Zonal AEO Program Manager.
2. Shri Vinay K. Singh, Additional Commissioner, AEO Cell
3. Shri Suraj Kumar Gupta, Deputy Commissioner, AEO Cell
4. Dr. Anchita Pandoh, Deputy Commissioner, AEO Cell

5. Henceforth, applications may be filed for AEO certification either with the Client Relationship Manager (CRM) already nominated for each Commissionerate,

including Jaipur and Ludhiana Customs Commissionerates. Alternatively, applications may also be filed with any of the above officers in the Zonal AEO Cell.


