**Office Order No. 07/TAR/2017**


With reference to the instructions contained in Board's Circular No.946/07/2011 dated 01.06.2011 issued vide F.No. 296/10/2009-CX.9, on the subject of write off of arrears of irrecoverable dues Board had decided to constitute three - member Committees of Chief Commissioners and Commissioners, which will examine the proposals for write - off of irrecoverable arrears and recommend deserving cases to the authority competent to order such write - off in terms of the Board's Circular dated 21.9.1990.

In compliance of the above Circular No.946/07/2011 dated 01.06.2011, Committees of Commissioners of Customs in Customs Delhi Zone were formed vide this office Order No. 1/TAR/2016, wherein Commissioner (TAR), Delhi was made a member in each of these committees. However, vide Circular No. 1059/8/2017-CX dated 03.10.2017, it has been directed by the Board that Commissioner (TAR) may not be made a member of these committees.

Consequently, in supersession to this Office Order No. 1/TAR/2016, the following Committees of Commissioners of Customs in Customs Delhi Zone are hereby re-constituted to examine the proposals for write-off of irrecoverable tax arrears and recommendation of the deserving cases to the Competent Authority:


