**Subject : Re-organization of Delhi Customs Zone and revised jurisdiction of the Customs Commissionerates – reg.**

It is to bring to the notice of Importers/Exporters/Customs Brokers/Members of the trade and others concerned that consequent upon the creation of **Customs (Airport & General) Commissionerate** by merger of erstwhile two Commissionerates, viz., IGI Airport and Customs (General) Commissionerate, in terms of Notification No.82/2017-Customs (N.T.) dated 24.08.2017 (as amended) and **Customs Audit Commissionerate**, in terms of Notification No.85/2017-Customs (N.T.) dated 07.09.2017 (as amended), the area of jurisdiction of Chief Commissioner of Customs, Delhi is being re-organized **w.e.f. 01-04-2018** as under :

- (i) Commissioner of Customs (Airport and General), Delhi;
- (ii) Principal Commissioner of Customs, Air Cargo Complex (Import), Delhi;
- (iii) Commissioner of Customs, Air Cargo Complex (Export), Delhi;
