PUBLIC NOTICE NO. 25/2011

In terms of provisions contained in Regulation 19 of Custom House Agents Licensing Regulation, 2004, it is proposed to conduct an examination on **06.11.2011** for 'H' card holder employee of Custom House Agents licensed in Delhi. All existing 'H' card holders, as on **30.06.2011**, are eligible to appear in the aforesaid examination.

In pursuance of Board Circular No. 21/2011-Customs dated 18.04.2011, all the Customs House Authorised Courier Agents operating in Delhi Customs Zone are also informed that the category 'G' card examination under Regulation 19 of the Custom House Agents Licensing Regulations (CHALR), 2004 will be conducted on the date mentioned above in para 1.

In view of the above referred circular, Director/Partner/Employee of Autohrised Courier agents, who have passed 10+2 or equivalent exam are eligible to appear for the Regulation 19 examination as per transition period extended upto 31.12.2011by the Board.

All eligible candidates may apply in the prescribed form available on the Departmental / Customs website : www.delhicustoms.gov.in and Notice Board of New Custom House, New Delhi. The form can be downloaded from the said website. No form will be issued from the Policy Branch. Application form duly filled should be accompanied by the following documents:

- (a) Two recent photographs (One photographs attested by the CHA / Authorised Courier Agent);
- (b) Certified copy of the CHA licence / Valid Courier Registration;
- (c) Certified copy of 'H' card / I-card of the Courier Company presently held;
- (d) Certified copy of proof of education qualification; and
- (e) Salary certified issued by CHA / Authorised Courier Agent.

The application form completed in all aspects alongwith enclosures should be submitted at the Centralized Dak System Counter, Ground Floor, New Custom House, New Delhi by not later than **05.00PM on 23.09.2011**. It is gain reiterated that no application form shall be

received in Policy Branch. Centralized Dak Counter shall issue acknowledgement on office copy of the application.

Roll Nos. will be displayed on or before 17.10.2011 on Departmental / Customs website and Notice Board of NCH, New Delhi. Admission cards will be issued to eligible candidates from **17.10.2011 to 21.10.2011 at 11:00AM to 05:00PM** from Special Sevottam Counter, New Custom House, New Delhi. Candidates are informed that they should not visit Policy Branch for admit cards. Time and place of examination may be confirmed from Notice Board of New Custom House or President, CHA Association office after 17.10.2011.

Note:

1. Application incomplete in any aspect or with wrong information will be rejected.
2. Only valid 'H' card holders as on **30.06.2010** and Director/Partner/Employee of Autohrised Courier agents are eligible.
3. Non appearance in the examination after issue of admission card shall be treated as chance availed.
4. Each candidate must bring his/her valid 'H' card / I-card and admission card, failing which he/she will not be permitted to appear in the examination.
