**TENDER NOTICE No. 04/2012**


The Commissioner of Customs, Air Cargo Export, New Customs House, New Delhi invites the sealed tenders for providing the services of approx. 20-25 unskilled workers for housekeeping, cleaning, dusting etc. on the following terms & conditions that :-

1. The contractor should be registered with service tax department with valid registration number.
2. The unskilled workers will be hired on prescribed rate of Delhi Govt. and the contractor will abide all the rules & regulations laid down under labour act and this office will not be responsible for any violation thereof.
3. The workers will work between 8:30AM to 5:00PM with half hour lunch break, six days a week i.e. Monday to Saturday and will do the work of housekeeping, cleaning and dusting of rooms tables, chairs, almirahs, loading & unloading work etc.
4. The workers provided by the contractor will be employees of their company and they will have no claim for employment in this Department.
5. The contractor is responsible for police verification of the workers deployed and a list of workers is required to be submitted to the Department.
6. The payment will be made by 15<sup>th</sup> day of next month after submitting the bill by the contractor.
7. The contract can be terminated at any time without assigning any reason thereof.
8. The contract shall be terminated and the payment shall be forfeited in case the work is not found satisfactory.
9. The contract will be awarded initially for a period of one year.

The interested parties may submit their tenders in a sealed cover latest by 27.09.2012 till 17:00 hrs. to the Administrative Officer (Admn.), Air Cargo Export, New Customs House, New Delhi-110037 in Room No. 230B. The tenders will be opened on 28.09.2012 at 11:00 AM in room No. 25, New Custom House, New Delhi in the presence of interested tenderer or their authorised representatives if they desire so.

The Commissioner of Customs, Air Cargo Export reserves the right to reject any or all the tenders without assigning any reason thereof and to call for any other detail or information from any of the tenderer.


