The said application should be sent by RPAD/Speed post or in person, so as to reach on or before 14/05/16 (upto 15.30 hours). Applications sent by other means will not be accepted. No application will be entertained after due date. The applications received will be opened on the next day i.e. 15/05/2016 at 16.00 hrs. At New Customs House, in presence of those applicants/their authorised representatives, who will be present.

PRE-QUALIFICATION CRITERIA

1. The applicant must have registered office/shop/establishment located within, Delhi/NCR.
2. The applicant must have valid Sales Tax Registration/Vat.
3. The applicant must have valid PAN card.
4. The applicant should be financially sound and solvent, copy of latest IT Return, bank statement for last six month, etc has to be submitted.
5. The applicant must have supplied similar materials of value Rs.50,000/- to any Govt./PSU/Autonomous body under Govt. During last three years for the category for which the firm has applied for registration. (Copy of purchase orders/bills to be submitted).

6. The applicant should have valid trade licence and all legal permissions.
7. Service tax Registration Certificate copy, where applicable should be submitted.
8. The applicant having dealership for a particular item/brand should mention clearly and submit copy in support of the same.

Please attach photo copies of all documents duly self-attested. This will be subject to verification and acceptance by "Customs".

2. Customs also reserves the right to make purchases from other party/parties who are not empanelled / registered.
