Please refer to the Public Notice No. 16/2020 dated 22.04.2020 issued by ACC Export Commissionerate, New Delhi.

2. Attention is invited to Circular No. 22/2020-Customs dated 21.04.2020 issued by CBIC in continuation of Circular No. 08/2018-Customs dated 23.03.2018, 15/2018-Customs dated 06.06.2018, 22/2018-Cus dated 18.07.2018, 40/2018-Customs dated 24.10.2018 and 26/2019-Cus dated 27.08.2019 wherein the Board has decided to extend the rectification facility for SB005 error cases covered for Shipping Bills filed up to 31.12.2019. SB005 error indicates mismatch of details of invoice shown in GSTR1 and details of invoice mentioned in Shipping Bill. In this regard, all Stakeholders are requested to take necessary steps to rectify SB005 error code by submitting Concordance Table (prescribed as per Annexure-A) along with relevant supporting documents viz. copy of relevant page of Shipping Bills, GSTR1/3B, as prescribed under CBIC's Circular No. 05/2018-Customs dated 23.02.2018 for the Shipping Bills filed on or before 31.12.2019.

3. Many shipping bills are pending for scroll generation due to error code SB003 (GSTIN mismatch). In this regard, it is requested to submit the under taking as per Circular No. 15/2018-Cus dated 06.06.2018 to Drawback section on mail ID: AccDbk.Delhi@icegate.gov.in (List of shipping bills with error code SB005 and SB003 is enclosed as Annexure-I).

4. It is also noticed that many shipping bills are pending for scroll generation due to error code SB002 (EGM not filed) and SB006 (Gateway EGM not available). In this regard, it is requested to approach the concerned Airlines for rectification of the EGM error (SB002 and SB006). (List of shipping bills with error code SB002 and SB006 is enclosed as Annexure-II)

5. Many shipping bills are pending for scroll generation due to PFMS error. In this regard, it is requested to send the IEC number and correct bank account details/cancelled cheque for updating to CRU section ACC Export on mail ID:- AccCru.Delhi@icegate.gov.in . It is also requested to get their KYC verified with their

concerned bank. (List of shipping bills with PFMS error is enclosed as Annexure-III).

6. All the lists as mentioned above have been uploaded on Delhi Customs website at <http://delhicustoms.gov.in> for the ready reference of the exporters.

7. The documents to be submitted to this office may be sent by exporter or his/her duly authorised representative through their authorized email id as registered with DGFT. The scanned copy of request letter along with the documents as necessary should be on the company/firm's official letter head and should be duly authenticated by the authorized signatory of the company/firm and are to be mailed to the concerned mail id.


