Subject: Renewal of self-sealing in EDI system - reg.

Attention of the Exporters, Customs Brokers and all concerned is invited to CBIC Circular No. 26/2017-Customs dated 01.07.2017, 36/2017-Customs dated 28.08.2017, 37/2017-Customs dated 20.09.2017 & 41/2017-Customs dated 30.10.2017 vide which the Board prescribed the procedure of self-sealing of containers by exporters using electronic seals.

2. Under the above Circulars the facility of self-sealing is provided to the exporters and the proper officer is granted the self-sealing permission to the exporters in EDI system for one year unless it is withdrawn. The representations of Exporters, Customs Brokers have been received for extension of validity period of self-sealing permission in EDI system.

3. As a facilitation measure, and for the sake of uniformity and ease of doing business, the registration of the self-sealing/certification in the EDI system shall be done for a period of 1 year in case of a merchant exporter for the first time and if nothing adverse is found, it shall be extended for 5 years in the subsequent years provided the beneficiary is a regular exporter and is exporting at least 6 consignment in a year availing the self-sealing facility and has not committed any export fraud or contravened any legal provision during this period. The enrolment of the self-sealing in the EDI system shall be done for a period of 5 years in case of manufacturer exporter.
