Subject: Special drive for disbursal of Pending cases of Brand Rate fixation at ICD, Patparganj and Other ICDs, Delhi.

Trade is hereby informed that a special drive has been launched for clearing old pending drawback cases. Attention of Trade and Industry is invited to cases of pending drawback in respect of Brand Rate Fixation which are lying pending with this Port/Commissionerate. The fixation of Brand rate of drawback is done under Rule 6 or 7 of the Customs, Central Excise & Service Tax Duties Drawback Rules, 1995 by the respective Commissioner of Central Excise & Customs under whose jurisdiction the manufacturer exporter/exporters falls. A list of all such pending shipping bills for this Commissionerate is enclosed ICD wise.

2. In this regard, all the exporters/CHAs are requested to contact this office within 10 days to submit a request along with relevant documents as are required to process cases of disbursal of drawback under Brand Rate Fixation, for their early disposal. In case the brand rate has not been fixed as yet, the name and details of jurisdictional Central Excise Commissionerate and concerned range where the brand rate application was filed, may also be intimated so that this office may contact concerned Commissionerate to expedite the same. The request along with intimation may also be e-mailed to this Commissionerate at sysmgr.ppg6@icegate.gov.in.


