Sub: - Drawback Clearance Drive - reg.

Reference is made to the Drawback claims pending with this office due to various reasons most of which are pending due to inaction on the part of exporters themselves.

2. In this regard, a large number of Drawback claims are pending from a long time due to non-submission of replies by the exporters to the queries raised in respect of their claims. The system is showing such claims as pending in the category of "Query raised to the Exporter". In the absence of non-submission of replies to these queries by the exporters, this office is not in a position to process their claims as the EDI system does not allow the same without submission of replies by the exporter. It is requested that the concerned exporters may be approached at your end and requested to submit their reply to the pending queries either on EDI portal or in person in the Drawback branch with the requisite documents. In case they face any problem due to current lock down situation, they may be advised to check the current status of their drawback claim on ICEGATE system and submit the replies on EDI portal itself so that this office is in a position to process their pending drawback claims after receipt of their replies to the pending queries. (A List of Shipping Bills pending for non-submission of reply to the queries is enclosed as Annexure-A for your kind reference).

3. Apart from the above, a lot of Drawback claims are also pending due to error in their respective EGM. Hence it is also requested to approach such exporters and advise them to contact the concerned airlines to get the EGM error rectified so that their pending claims are processed at this end. (List of Shipping Bills pending due to EGM Error is enclosed as Annexure-B).

4. Further, some cases of drawback claims are also pending due to PFMS error. In this regard, the exporters are advised to send their IEC number with correct bank account details/cancelled cheque to the CRU section for updating the same in the EDI system at the mail ID: -AccCru.Delhi@icegate.gov.in. They

may also be advised to approach their concerned bank for updating their KYC with the Bank. (List of ~~ICEG~~ **JECs WITH** PFMS error is enclosed as Annexure-C)

5. All the lists as mentioned above have also been uploaded on <http://delhicustoms.gov.in> for ready reference of the concerned exporters.


6. The documents required to be submitted to this office may be sent by the exporter or his/her duly authorised representative through their authorized email id as registered with DGFT. The scanned copy of the request letter along with the necessary documents should be on the company/firm's official letter head and are to be duly authenticated by the authorized signatory of the company/firm and mailed to the concerned mail id.

7. Difficulty, if any, may please be brought to the notice of Deputy Commissioner (DBK) ACC Export at AccDbk.Delhi@icegate.gov.in.

8. All the Customs Brokers & Trade associations and other concerned are requested to contact the concerned exporters on priority so that their pending claims are processed at the earliest.


